- Contestants and Owners must be a current NRCHA & IRCHA Members in classes approved by those Associations.
- A copy of horse's registration papers or a vet description of horse's age must accompany entry.

The Open Amateur Bridle \$1500 Class & is an ImRCHA approved classes. They are not NRCHA approved classes.

- This class is for Non-Pros who have not won more than \$1500 in Reined Cow Horse competition as of 12/31/09.
- This class is intended to be a "stepping" stone for those of you who are just starting out or maybe wanting to move out of the Non-Pro limited (boxing) class. If this describes YOU, please take advantage of this class.
- NP Limited contestants, remember that you can go down the fence up to 2 times and still go back to the NP Limited class.
